The deadline is July 15, 2026!

The nomination period for the FSA County Committee is now open. For 2026, the Benton/Mille Lacs FSA office has 2 areas up for nomination. For Benton County, the election will take place in LAA #3, which consists of the following Townships: Watab, Mayhew Lake, Gilmanton, Maywood, Sauk Rapids, and Minden. For Mille Lacs County, an election will take place in LAA #5, which consists of the following Townships: Borgholm, Bogus Brook, and Princeton. Nominations must be turned in by August 3, 2026. If you reside in one of these areas, please consider nominating yourself or a qualified candidate to represent your area on the County Committee.
